## 34. KINEMATICS

Revised January 2000 by J.D. Jackson (LBNL).
Throughout this section units are used in which $\hbar=c=1$. The following conversions are useful: $\hbar c=197.3 \mathrm{MeV} \mathrm{fm},(\hbar c)^{2}=0.3894$ $(\mathrm{GeV})^{2} \mathrm{mb}$.

### 34.1. Lorentz transformations

The energy $E$ and 3-momentum $\boldsymbol{p}$ of a particle of mass $m$ form a 4 -vector $p=(E, \boldsymbol{p})$ whose square $p^{2} \equiv E^{2}-|\boldsymbol{p}|^{2}=m^{2}$. The velocity of the particle is $\boldsymbol{\beta}=\boldsymbol{p} / E$. The energy and momentum $\left(E^{*}, \boldsymbol{p}^{*}\right)$ viewed from a frame moving with velocity $\boldsymbol{\beta}_{f}$ are given by

$$
\binom{E^{*}}{p_{\|}^{*}}=\left(\begin{array}{cc}
\gamma_{f} & -\gamma_{f} \beta_{f}  \tag{34.1}\\
-\gamma_{f} \beta_{f} & \gamma_{f}
\end{array}\right)\binom{E}{p_{\|}}, \quad p_{T}^{*}=p_{T}
$$

where $\gamma_{f}=\left(1-\beta_{f}^{2}\right)^{-1 / 2}$ and $p_{T}\left(p_{\|}\right)$are the components of $\boldsymbol{p}$ perpendicular (parallel) to $\boldsymbol{\beta}_{f}$. Other 4 -vectors, such as the spacetime coordinates of events, of course transform in the same way. The scalar product of two 4 -momenta $p_{1} \cdot p_{2}=E_{1} E_{2}-\boldsymbol{p}_{1} \cdot \boldsymbol{p}_{2}$ is invariant (frame independent).

### 34.2. Center-of-mass energy and momentum

In the collision of two particles of masses $m_{1}$ and $m_{2}$ the total center-of-mass energy can be expressed in the Lorentz-invariant form

$$
\begin{align*}
E_{\mathrm{cm}} & =\left[\left(E_{1}+E_{2}\right)^{2}-\left(\boldsymbol{p}_{1}+\boldsymbol{p}_{2}\right)^{2}\right]^{1 / 2} \\
& =\left[m_{1}^{2}+m_{2}^{2}+2 E_{1} E_{2}\left(1-\beta_{1} \beta_{2} \cos \theta\right)\right]^{1 / 2} \tag{34.2}
\end{align*}
$$

where $\theta$ is the angle between the particles. In the frame where one particle (of mass $m_{2}$ ) is at rest (lab frame),

$$
\begin{equation*}
E_{\mathrm{cm}}=\left(m_{1}^{2}+m_{2}^{2}+2 E_{1 \mathrm{lab}} m_{2}\right)^{1 / 2} \tag{34.3}
\end{equation*}
$$

The velocity of the center-of-mass in the lab frame is

$$
\begin{equation*}
\boldsymbol{\beta}_{\mathrm{cm}}=\boldsymbol{p}_{\mathrm{lab}} /\left(E_{1 \mathrm{lab}}+m_{2}\right) \tag{34.4}
\end{equation*}
$$

where $\boldsymbol{p}_{\text {lab }} \equiv \boldsymbol{p}_{1 \text { lab }}$ and

$$
\begin{equation*}
\gamma_{\mathrm{cm}}=\left(E_{1 \mathrm{lab}}+m_{2}\right) / E_{\mathrm{cm}} \tag{34.5}
\end{equation*}
$$

The c.m. momenta of particles 1 and 2 are of magnitude

$$
\begin{equation*}
p_{\mathrm{cm}}=p_{\mathrm{lab}} \frac{m_{2}}{E_{\mathrm{cm}}} \tag{34.6}
\end{equation*}
$$

For example, if a $0.80 \mathrm{GeV} / c$ kaon beam is incident on a proton target, the center of mass energy is 1.699 GeV and the center of mass momentum of either particle is $0.442 \mathrm{GeV} / c$. It is also useful to note that

$$
\begin{equation*}
E_{\mathrm{cm}} d E_{\mathrm{cm}}=m_{2} d E_{1 \mathrm{lab}}=m_{2} \beta_{1 \mathrm{lab}} d p_{\mathrm{lab}} \tag{34.7}
\end{equation*}
$$

### 34.3. Lorentz-invariant amplitudes

The matrix elements for a scattering or decay process are written in terms of an invariant amplitude $-i \mathscr{M}$. As an example, the $S$-matrix for $2 \rightarrow 2$ scattering is related to $\mathscr{M}$ by

\begin{align*}
\left\langle p_{1}^{\prime} p_{2}^{\prime}\right| S\left|p_{1} p_{2}\right\rangle & =I-i(2 \pi)^{4} \delta^{4}\left(p_{1}+p_{2}-p_{1}^{\prime}-p_{2}^{\prime}\right) \\
& \times \frac{\mathscr{M}\left(p_{1}, p_{2} ; p_{1}^{\prime}, p_{2}^{\prime}\right)}{\left(2 E_{1}\right)^{1 / 2}\left(2 E_{2}\right)^{1 / 2}\left(2 E_{1}^{\prime}\right)^{1 / 2}\left(2 E_{2}^{\prime}\right)^{1 / 2}} \tag{34.8}
\end{align*}
$$

The state normalization is such that

$$
\begin{equation*}
\left\langle p^{\prime} \mid p\right\rangle=(2 \pi)^{3} \delta^{3}\left(\boldsymbol{p}-\boldsymbol{p}^{\prime}\right) \tag{34.9}
\end{equation*}
$$

### 34.4. Particle decays

The partial decay rate of a particle of mass $M$ into $n$ bodies in its rest frame is given in terms of the Lorentz-invariant matrix element $\mathscr{M}$ by

$$
\begin{equation*}
d \Gamma=\frac{(2 \pi)^{4}}{2 M}|\mathscr{M}|^{2} d \Phi_{n}\left(P ; p_{1}, \ldots, p_{n}\right) \tag{34.10}
\end{equation*}
$$

where $d \Phi_{n}$ is an element of $n$-body phase space given by

$$
\begin{equation*}
d \Phi_{n}\left(P ; p_{1}, \ldots, p_{n}\right)=\delta^{4}\left(P-\sum_{i=1}^{n} p_{i}\right) \prod_{i=1}^{n} \frac{d^{3} p_{i}}{(2 \pi)^{3} 2 E_{i}} \tag{34.11}
\end{equation*}
$$

This phase space can be generated recursively, viz.

$$
\begin{gather*}
d \Phi_{n}\left(P ; p_{1}, \ldots, p_{n}\right)=d \Phi_{j}\left(q ; p_{1}, \ldots, p_{j}\right) \\
\times d \Phi_{n-j+1}\left(P ; q, p_{i+1}, \ldots, p_{n}\right)(2 \pi)^{3} d q^{2} \tag{34.12}
\end{gather*}
$$

where $q^{2}=\left(\sum_{i=1}^{j} E_{i}\right)^{2}-\left|\sum_{i=1}^{j} \boldsymbol{p}_{i}\right|^{2}$. This form is particularly useful in the case where a particle decays into another particle that subsequently decays.
34.4.1. Survival probability: If a particle of mass $M$ has mean proper lifetime $\tau(=1 / \Gamma)$ and has momentum $(E, \boldsymbol{p})$, then the probability that it lives for a time $t_{0}$ or greater before decaying is given by

$$
\begin{equation*}
P\left(t_{0}\right)=e^{-t_{0} \Gamma / \gamma}=e^{-M t_{0} \Gamma / E} \tag{34.13}
\end{equation*}
$$

and the probability that it travels a distance $x_{0}$ or greater is

$$
\begin{equation*}
P\left(x_{0}\right)=e^{-M x_{0} \Gamma /|\boldsymbol{p}|} \tag{34.14}
\end{equation*}
$$

### 34.4.2. Two-body decays:



Figure 34.1: Definitions of variables for two-body decays.

In the rest frame of a particle of mass $M$, decaying into 2 particles labeled 1 and 2,

$$
\begin{gather*}
E_{1}=\frac{M^{2}-m_{2}^{2}+m_{1}^{2}}{2 M},  \tag{34.15}\\
=\frac{\left|\boldsymbol{p}_{1}\right|=\left|\boldsymbol{p}_{2}\right|}{\left[\left(M^{2}-\left(m_{1}+m_{2}\right)^{2}\right)\left(M^{2}-\left(m_{1}-m_{2}\right)^{2}\right)\right]^{1 / 2}} \\
2 M \tag{34.16}
\end{gather*},
$$

and

$$
\begin{equation*}
d \Gamma=\frac{1}{32 \pi^{2}}|\mathscr{M}|^{2} \frac{\left|\boldsymbol{p}_{1}\right|}{M^{2}} d \Omega \tag{34.17}
\end{equation*}
$$

where $d \Omega=d \phi_{1} d\left(\cos \theta_{1}\right)$ is the solid angle of particle 1 .

### 34.4.3. Three-body decays:



Figure 34.2: Definitions of variables for three-body decays.

Defining $p_{i j}=p_{i}+p_{j}$ and $m_{i j}^{2}=p_{i j}^{2}$, then $m_{12}^{2}+m_{23}^{2}+m_{13}^{2}=$ $M^{2}+m_{1}^{2}+m_{2}^{2}+m_{3}^{2}$ and $m_{12}^{2}=\left(P-p_{3}\right)^{2}=M^{2}+m_{3}^{2}-2 M E_{3}$, where $E_{3}$ is the energy of particle 3 in the rest frame of $M$. In that frame, the momenta of the three decay particles lie in a plane. The relative orientation of these three momenta is fixed if their energies are known. The momenta can therefore be specified in space by giving three Euler angles $(\alpha, \beta, \gamma)$ that specify the orientation of the final system relative to the initial particle [1]. Then

$$
\begin{equation*}
d \Gamma=\frac{1}{(2 \pi)^{5}} \frac{1}{16 M}|\mathscr{M}|^{2} d E_{1} d E_{2} d \alpha d(\cos \beta) d \gamma . \tag{34.18}
\end{equation*}
$$

Alternatively

$$
\begin{equation*}
d \Gamma=\frac{1}{(2 \pi)^{5}} \frac{1}{16 M^{2}}|\mathscr{M}|^{2}\left|\boldsymbol{p}_{1}^{*}\right|\left|\boldsymbol{p}_{3}\right| d m_{12} d \Omega_{1}^{*} d \Omega_{3}, \tag{34.19}
\end{equation*}
$$

where $\left(\left|p_{1}^{*}\right|, \Omega_{1}^{*}\right)$ is the momentum of particle 1 in the rest frame of 1 and 2 , and $\Omega_{3}$ is the angle of particle 3 in the rest frame of the decaying particle. $\left|\boldsymbol{p}_{1}^{*}\right|$ and $\left|\boldsymbol{p}_{3}\right|$ are given by

$$
\begin{equation*}
\left|\boldsymbol{p}_{1}^{*}\right|=\frac{\left[\left(m_{12}^{2}-\left(m_{1}+m_{2}\right)^{2}\right)\left(m_{12}^{2}-\left(m_{1}-m_{2}\right)^{2}\right)\right]^{1 / 2}}{2 m_{12}} \tag{34.20a}
\end{equation*}
$$

and

$$
\begin{equation*}
\left|\boldsymbol{p}_{3}\right|=\frac{\left[\left(M^{2}-\left(m_{12}+m_{3}\right)^{2}\right)\left(M^{2}-\left(m_{12}-m_{3}\right)^{2}\right)\right]^{1 / 2}}{2 M} \tag{34.20b}
\end{equation*}
$$

[Compare with Eq. (34.16).]
If the decaying particle is a scalar or we average over its spin states, then integration over the angles in Eq. (34.18) gives

$$
\begin{align*}
& d \Gamma=\frac{1}{(2 \pi)^{3}} \frac{1}{8 M} \overline{|\mathscr{M}|^{2}} d E_{1} d E_{2} \\
& =\frac{1}{(2 \pi)^{3}} \frac{1}{32 M^{3}} \overline{|\mathscr{M}|^{2}} d m_{12}^{2} d m_{23}^{2} . \tag{34.21}
\end{align*}
$$

This is the standard form for the Dalitz plot.
34.4.3.1. Dalitz plot: For a given value of $m_{12}^{2}$, the range of $m_{23}^{2}$ is determined by its values when $\boldsymbol{p}_{2}$ is parallel or antiparallel to $\boldsymbol{p}_{3}$ :

$$
\begin{gather*}
\left(m_{23}^{2}\right)_{\max }= \\
\left(E_{2}^{*}+E_{3}^{*}\right)^{2}-\left(\sqrt{E_{2}^{* 2}-m_{2}^{2}}-\sqrt{E_{3}^{* 2}-m_{3}^{2}}\right)^{2}  \tag{34.22a}\\
\left(m_{23}^{2}\right)_{\min }= \\
\left(E_{2}^{*}+E_{3}^{*}\right)^{2}-\left(\sqrt{E_{2}^{* 2}-m_{2}^{2}}+\sqrt{E_{3}^{* 2}-m_{3}^{2}}\right)^{2} . \tag{34.22b}
\end{gather*}
$$

Here $E_{2}^{*}=\left(m_{12}^{2}-m_{1}^{2}+m_{2}^{2}\right) / 2 m_{12}$ and $E_{3}^{*}=\left(M^{2}-m_{12}^{2}-m_{3}^{2}\right) / 2 m_{12}$ are the energies of particles 2 and 3 in the $m_{12}$ rest frame. The scatter plot in $m_{12}^{2}$ and $m_{23}^{2}$ is called a Dalitz plot. If $\overline{|\mathscr{M}|^{2}}$ is constant, the allowed region of the plot will be uniformly populated with events [see Eq. (34.21)]. A nonuniformity in the plot gives immediate information on $|\mathscr{M}|^{2}$. For example, in the case of $D \rightarrow K \pi \pi$, bands appear when $m_{(K \pi)}=m_{K^{*}(892)}$, reflecting the appearance of the decay chain $D \rightarrow K^{*}(892) \pi \rightarrow K \pi \pi$.
34.4.4. Kinematic limits: In a three-body decay the maximum of $\left|\boldsymbol{p}_{3}\right|$, [given by Eq. (34.20)], is achieved when $m_{12}=m_{1}+m_{2}$, i.e., particles 1 and 2 have the same vector velocity in the rest frame of the decaying particle. If, in addition, $m_{3}>m_{1}, m_{2}$, then $\left|\boldsymbol{p}_{3}\right|_{\text {max }}>\left|\boldsymbol{p}_{1}\right|_{\text {max }},\left|\boldsymbol{p}_{2}\right|_{\text {max }}$.


Figure 34.3: Dalitz plot for a three-body final state. In this example, the state is $\pi^{+} \bar{K}^{0} p$ at 3 GeV . Four-momentum conservation restricts events to the shaded region.
34.4.5. Multibody decays: The above results may be generalized to final states containing any number of particles by combining some of the particles into "effective particles" and treating the final states as 2 or 3 "effective particle" states. Thus, if $p_{i j k \ldots}=p_{i}+p_{j}+p_{k}+\ldots$, then

$$
\begin{equation*}
m_{i j k \ldots}=\sqrt{p^{2}{ }_{i j k \ldots \ldots}}, \tag{34.23}
\end{equation*}
$$

and $m_{i j k \ldots}$ may be used in place of e.g., $m_{12}$ in the relations in Sec. 34.4.3 or 34.4.3.1 above.


Figure 34.4: Definitions of variables for production of an $n$-body final state.

### 34.5. Cross sections

The differential cross section is given by

$$
\begin{align*}
& d \sigma=\frac{(2 \pi)^{4}|\mathscr{M}|^{2}}{4 \sqrt{\left(p_{1} \cdot p_{2}\right)^{2}-m_{1}^{2} m_{2}^{2}}} \\
& \times d \Phi_{n}\left(p_{1}+p_{2} ; p_{3}, \ldots, p_{n+2}\right) . \tag{34.24}
\end{align*}
$$

[See Eq. (34.11).] In the rest frame of $m_{2}$ (lab),

$$
\begin{equation*}
\sqrt{\left(p_{1} \cdot p_{2}\right)^{2}-m_{1}^{2} m_{2}^{2}}=m_{2} p_{1 \mathrm{lab}} ; \tag{34.25a}
\end{equation*}
$$

while in the center-of-mass frame

$$
\begin{equation*}
\sqrt{\left(p_{1} \cdot p_{2}\right)^{2}-m_{1}^{2} m_{2}^{2}}=p_{1 \mathrm{~cm}} \sqrt{s} . \tag{34.25b}
\end{equation*}
$$

### 34.5.1. Two-body reactions:



Figure 34.5: Definitions of variables for a two-body final state.

Two particles of momenta $p_{1}$ and $p_{2}$ and masses $m_{1}$ and $m_{2}$ scatter to particles of momenta $p_{3}$ and $p_{4}$ and masses $m_{3}$ and $m_{4}$; the Lorentz-invariant Mandelstam variables are defined by

$$
\begin{align*}
s & =\left(p_{1}+p_{2}\right)^{2}=\left(p_{3}+p_{4}\right)^{2} \\
& =m_{1}^{2}+2 E_{1} E_{2}-2 \boldsymbol{p}_{1} \cdot \boldsymbol{p}_{2}+m_{2}^{2}  \tag{34.26}\\
t & =\left(p_{1}-p_{3}\right)^{2}=\left(p_{2}-p_{4}\right)^{2} \\
& =m_{1}^{2}-2 E_{1} E_{3}+2 \boldsymbol{p}_{1} \cdot \boldsymbol{p}_{3}+m_{3}^{2}  \tag{34.27}\\
u & =\left(p_{1}-p_{4}\right)^{2}=\left(p_{2}-p_{3}\right)^{2} \\
& =m_{1}^{2}-2 E_{1} E_{4}+2 \boldsymbol{p}_{1} \cdot \boldsymbol{p}_{4}+m_{4}^{2} \tag{34.28}
\end{align*}
$$

and they satisfy

$$
\begin{equation*}
s+t+u=m_{1}^{2}+m_{2}^{2}+m_{3}^{2}+m_{4}^{2} \tag{34.29}
\end{equation*}
$$

The two-body cross section may be written as

$$
\begin{equation*}
\frac{d \sigma}{d t}=\frac{1}{64 \pi s} \frac{1}{\left|\boldsymbol{p}_{1 \mathrm{~cm}}\right|^{2}}|\mathscr{M}|^{2} \tag{34.30}
\end{equation*}
$$

In the center-of-mass frame

$$
\begin{gather*}
t=\left(E_{1 \mathrm{~cm}}-E_{3 \mathrm{~cm}}\right)^{2}-\left(p_{1 \mathrm{~cm}}-p_{3 \mathrm{~cm}}\right)^{2} \quad-4 p_{1 \mathrm{~cm}} p_{3 \mathrm{~cm}} \sin ^{2}\left(\theta_{\mathrm{cm}} / 2\right) \\
=t_{0}-4 p_{1 \mathrm{~cm}} p_{3 \mathrm{~cm}} \sin ^{2}\left(\theta_{\mathrm{cm}} / 2\right), \tag{34.31}
\end{gather*}
$$

where $\theta_{\mathrm{cm}}$ is the angle between particle 1 and 3 . The limiting values $t_{0} \quad\left(\theta_{\mathrm{cm}}=0\right)$ and $t_{1}\left(\theta_{\mathrm{cm}}=\pi\right)$ for $2 \rightarrow 2$ scattering are

$$
\begin{equation*}
t_{0}\left(t_{1}\right)=\left[\frac{m_{1}^{2}-m_{3}^{2}-m_{2}^{2}+m_{4}^{2}}{2 \sqrt{s}}\right]^{2}-\left(p_{1 \mathrm{~cm}} \mp p_{3 \mathrm{~cm}}\right)^{2} \tag{34.32}
\end{equation*}
$$

In the literature the notation $t_{\min }\left(t_{\max }\right)$ for $t_{0}\left(t_{1}\right)$ is sometimes used, which should be discouraged since $t_{0}>t_{1}$. The center-of-mass energies and momenta of the incoming particles are

$$
\begin{equation*}
E_{1 \mathrm{~cm}}=\frac{s+m_{1}^{2}-m_{2}^{2}}{2 \sqrt{s}}, \quad E_{2 \mathrm{~cm}}=\frac{s+m_{2}^{2}-m_{1}^{2}}{2 \sqrt{s}} \tag{34.33}
\end{equation*}
$$

For $E_{3 \mathrm{~cm}}$ and $E_{4 \mathrm{~cm}}$, change $m_{1}$ to $m_{3}$ and $m_{2}$ to $m_{4}$. Then

$$
\begin{equation*}
p_{i \mathrm{~cm}}=\sqrt{E_{i \mathrm{~cm}}^{2}-m_{i}^{2}} \text { and } p_{1 \mathrm{~cm}}=\frac{p_{1 \mathrm{lab}} m_{2}}{\sqrt{s}} \tag{34.34}
\end{equation*}
$$

Here the subscript lab refers to the frame where particle 2 is at rest. [For other relations see Eqs. (34.2)-(34.4).]
34.5.2. Inclusive reactions: Choose some direction (usually the beam direction) for the $z$-axis; then the energy and momentum of a particle can be written as

$$
\begin{equation*}
E=m_{T} \cosh y, p_{x}, p_{y}, p_{z}=m_{T} \sinh y \tag{34.35}
\end{equation*}
$$

where $m_{T}$ is the transverse mass

$$
\begin{equation*}
m_{T}^{2}=m^{2}+p_{x}^{2}+p_{y}^{2} \tag{34.36}
\end{equation*}
$$

and the rapidity $y$ is defined by

$$
\begin{gather*}
y=\frac{1}{2} \ln \left(\frac{E+p_{z}}{E-p_{z}}\right) \\
=\ln \left(\frac{E+p_{z}}{m_{T}}\right)=\tanh ^{-1}\left(\frac{p_{z}}{E}\right) \tag{34.37}
\end{gather*}
$$

Under a boost in the $z$-direction to a frame with velocity $\beta$, $y \rightarrow y-\tanh ^{-1} \beta$. Hence the shape of the rapidity distribution $d N / d y$ is invariant. The invariant cross section may also be rewritten

$$
\begin{equation*}
E \frac{d^{3} \sigma}{d^{3} p}=\frac{d^{3} \sigma}{d \phi d y p_{T} d p_{T}} \Longrightarrow \frac{d^{2} \sigma}{\pi d y d\left(p_{T}^{2}\right)} \tag{34.38}
\end{equation*}
$$

The second form is obtained using the identity $d y / d p_{z}=1 / E$, and the third form represents the average over $\phi$.

Feynman's $x$ variable is given by

$$
\begin{equation*}
x=\frac{p_{z}}{p_{z \max }} \approx \frac{E+p_{z}}{\left(E+p_{z}\right)_{\max }} \quad\left(p_{T} \ll\left|p_{z}\right|\right) \tag{34.39}
\end{equation*}
$$

In the c.m. frame,

$$
\begin{equation*}
x \approx \frac{2 p_{z \mathrm{~cm}}}{\sqrt{s}}=\frac{2 m_{T} \sinh y_{\mathrm{cm}}}{\sqrt{s}} \tag{34.40}
\end{equation*}
$$

and

$$
\begin{equation*}
=\left(y_{\mathrm{cm}}\right)_{\max }=\ln (\sqrt{s} / m) \tag{34.41}
\end{equation*}
$$

For $p \gg m$, the rapidity [Eq. (34.37)] may be expanded to obtain

$$
\begin{gather*}
y=\frac{1}{2} \ln \frac{\cos ^{2}(\theta / 2)+m^{2} / 4 p^{2}+\ldots}{\sin ^{2}(\theta / 2)+m^{2} / 4 p^{2}+\ldots} \\
\approx-\ln \tan (\theta / 2) \equiv \eta \tag{34.42}
\end{gather*}
$$

where $\cos \theta=p_{z} / p$. The pseudorapidity $\eta$ defined by the second line is approximately equal to the rapidity $y$ for $p \gg m$ and $\theta \gg 1 / \gamma$, and in any case can be measured when the mass and momentum of the particle is unknown. From the definition one can obtain the identities

$$
\begin{equation*}
\sinh \eta=\cot \theta, \quad \cosh \eta=1 / \sin \theta, \quad \tanh \eta=\cos \theta \tag{34.43}
\end{equation*}
$$

34.5.3. Partial waves: The amplitude in the center of mass for elastic scattering of spinless particles may be expanded in Legendre polynomials

$$
\begin{equation*}
f(k, \theta)=\frac{1}{k} \sum_{\ell}(2 \ell+1) a_{\ell} P_{\ell}(\cos \theta) \tag{34.44}
\end{equation*}
$$

where $k$ is the c.m. momentum, $\theta$ is the c.m. scattering angle, $a_{\ell}$ $=\left(\eta_{\ell} e^{2 i \delta_{\ell}}-1\right) / 2 i, 0 \leq \eta_{\ell} \leq 1$, and $\delta_{\ell}$ is the phase shift of the $\ell^{t h}$ partial wave. For purely elastic scattering, $\eta_{\ell}=1$. The differential cross section is

$$
\begin{equation*}
\frac{d \sigma}{d \Omega}=|f(k, \theta)|^{2} \tag{34.45}
\end{equation*}
$$

The optical theorem states that

$$
\begin{equation*}
\sigma_{\mathrm{tot}}=\frac{4 \pi}{k} \operatorname{Im} f(k, 0) \tag{34.46}
\end{equation*}
$$

and the cross section in the $\ell^{t h}$ partial wave is therefore bounded:

$$
\begin{equation*}
\sigma_{\ell}=\frac{4 \pi}{k^{2}}(2 \ell+1)\left|a_{\ell}\right|^{2} \leq \frac{4 \pi(2 \ell+1)}{k^{2}} \tag{34.47}
\end{equation*}
$$

The evolution with energy of a partial-wave amplitude $a_{\ell}$ can be displayed as a trajectory in an Argand plot, as shown in Fig. 34.6.


Figure 34.6: Argand plot showing a partial-wave amplitude $a_{\ell}$ as a function of energy. The amplitude leaves the unitary circle where inelasticity sets in $\left(\eta_{\ell}<1\right)$.

The usual Lorentz-invariant matrix element $\mathscr{M}$ (see Sec. 34.3 above) for the elastic process is related to $f(k, \theta)$ by

$$
\begin{equation*}
\mathscr{M}=-8 \pi \sqrt{s} f(k, \theta) \tag{34.48}
\end{equation*}
$$

so

$$
\begin{equation*}
\sigma_{\mathrm{tot}}=-\frac{1}{2 p_{\text {lab }} m_{2}} \operatorname{Im} \mathscr{M}(t=0) \tag{34.49}
\end{equation*}
$$

where $s$ and $t$ are the center-of-mass energy squared and momentum transfer squared, respectively (see Sec. 34.4.1).
34.5.3.1. Resonances: The Breit-Wigner (nonrelativistic) form for an elastic amplitude $a_{\ell}$ with a resonance at c.m. energy $E_{R}$, elastic width $\Gamma_{\mathrm{el}}$, and total width $\Gamma_{\text {tot }}$ is

$$
\begin{equation*}
a_{\ell}=\frac{\Gamma_{\mathrm{el}} / 2}{E_{R}-E-i \Gamma_{\mathrm{tot}} / 2} \tag{34.50}
\end{equation*}
$$

where $E$ is the c.m. energy. As shown in Fig. 34.7, in the absence of background the elastic amplitude traces a counterclockwise circle with center $i x_{\mathrm{el}} / 2$ and radius $x_{\mathrm{el}} / 2$, where the elasticity $x_{\mathrm{el}}=\Gamma_{\mathrm{el}} / \Gamma_{\text {tot }}$. The amplitude has a pole at $E=E_{R}-i \Gamma_{\text {tot }} / 2$.

The spin-averaged Breit-Wigner cross section for a spin- $J$ resonance produced in the collision of particles of spin $S_{1}$ and $S_{2}$ is

$$
\begin{equation*}
\sigma_{B W}(E)=\frac{(2 J+1)}{\left(2 S_{1}+1\right)\left(2 S_{2}+1\right)} \frac{\pi}{k^{2}} \frac{B_{\mathrm{in}} B_{\mathrm{out}} \Gamma_{\mathrm{tot}}^{2}}{\left(E-E_{R}\right)^{2}+\Gamma_{\mathrm{tot}}^{2} / 4} \tag{34.51}
\end{equation*}
$$

where $k$ is the c.m. momentum, $E$ is the c.m. energy, and $B_{\text {in }}$ and $B_{\text {out }}$ are the branching fractions of the resonance into the entrance and exit channels. The $2 S+1$ factors are the multiplicities of the incident spin states, and are replaced by 2 for photons. This expression is valid only for an isolated state. If the width is not small, $\Gamma_{\text {tot }}$ cannot be treated as a constant independent of $E$. There are many other forms for $\sigma_{B W}$, all of which are equivalent to the one given here in the narrow-width case. Some of these forms may be more appropriate if the resonance is broad.


Figure 34.7: Argand plot for a resonance.

The relativistic Breit-Wigner form corresponding to Eq. (34.50) is:

$$
\begin{equation*}
a_{\ell}=\frac{-m \Gamma_{\mathrm{el}}}{s-m^{2}+i m \Gamma_{\mathrm{tot}}} . \tag{34.52}
\end{equation*}
$$

A better form incorporates the known kinematic dependences, replacing $m \Gamma_{\text {tot }}$ by $\sqrt{s} \Gamma_{\text {tot }}(s)$, where $\Gamma_{\text {tot }}(s)$ is the width the resonance particle would have if its mass were $\sqrt{s}$, and correspondingly $m \Gamma_{\text {el }}$ by $\sqrt{s} \Gamma_{\mathrm{el}}(s)$ where $\Gamma_{\mathrm{el}}(s)$ is the partial width in the incident channel for a mass $\sqrt{s}$ :

$$
\begin{equation*}
a_{\ell}=\frac{-\sqrt{s} \Gamma_{\mathrm{el}}(s)}{s-m^{2}+i \sqrt{s} \Gamma_{\mathrm{tot}}(s)} . \tag{34.53}
\end{equation*}
$$

For the $Z$ boson, all the decays are to particles whose masses are small enough to be ignored, so on dimensional grounds $\Gamma_{\text {tot }}(s)=\sqrt{s} \Gamma_{0} / m_{Z}$, where $\Gamma_{0}$ defines the width of the $Z$, and $\Gamma_{\mathrm{el}}(s) / \Gamma_{\text {tot }}(s)$ is constant. A full treatment of the line shape requires consideration of dynamics, not just kinematics. For the $Z$ this is done by calculating the radiative corrections in the Standard Model.
