## Magnetic Monopole Searches

Isolated supermassive monopole candidate events have not been confirmed. The most sensitive experiments obtain negative results.

Best cosmic-ray supermassive monopole flux limit:

## Supersymmetric Particle Searches

Limits are based on the Minimal Supersymmetric Standard Model.
Assumptions include: 1) $\widetilde{\chi}_{1}^{0}$ (or $\widetilde{\gamma}$ ) is lightest supersymmetric particle;
2) $R$-parity is conserved; 3) With the exception of $\widetilde{t}$ and $\widetilde{b}$, all scalar quarks are assumed to be degenerate in mass and $m_{\widetilde{q}_{R}}=m_{\widetilde{q}_{L}} .4$ Limits for sleptons refer to the $\tilde{\ell}_{R}$ states. 5) Gaugino mass unification at the GUT scale.
